The Board of Clark County Commissioners met in regular session pursuant to adjournment in accordance with Section 121.22 O.R.C. (Sunshine Law) at the Commission Office, 50 East Columbia Street, Springfield, Ohio.

The following members and guests were present: Commissioner Melanie Flax Wilt; Commissioner Richard L. Lohnes; Commissioner Lowell R. McGlothin; Jenny Hutchinson, County Administrator; Michelle R. Noble, Assistant County Administrator/HR Director; Megan Burr, Commission Clerk; Michael Cooper, Clark County Public Information Officer; John Federer, County Auditor; Bill Wolfarth, OIC.

Commissioner Lohnes reviewed his notes and said the Commission funded the cognitive piece. He mentioned the Medicaid sales tax loss in revenue. The county was trying to properly react to that. Commissioner Lohnes noted if they request more than \$50,000 it triggers a different set of procedures. OIC requested \$24,500 for the case manager and \$50,000 for the coordinator. Commissioner Lohnes said the requests from outside entities will be discussed next week. He thought speaking to Mr. Wolfarth might help clarify OIC's funding requests. Mr. Wolfarth felt it was a small amount of money to spend for the return.

Agenda Review:

Commissioner Wilt asked about the following resolutions:

Resolution 2019-0003 was the decision on the annexation. Commissioner Lohnes read the Engineer's letter. There were five issues with that map that were not complete according to the County Engineer. The Board felt they should deny the request based on those inaccuracies.

They reviewed the other reorganization resolutions. Commissioner Wilt asked if the Board met the required 50 meetings for 2018. Mrs. Burr replied yes. The Commissioners were ok with the meeting schedule.
