Industrial District) to City M-1 (City of Springfield, General Manufacturing District)

Chairperson Hanlon asked for the staff report.

Mr. Neimayer stated the subject property is located at 1801, 1820, 1830 & 1860 Prime Parkway and consists of a total of 175.78 acres owned by CIC. He said the property was originally zoned I-2 in May 1974, when zoning was adopted for Springfield Township and has remained as I-2. When the subject property was annexed into the City of Springfield in 2011, the Twp I-2 zoning was carried. He stated due to height restrictions under Twp I-2, and to be consistent with zoning for Prime Ohio I, the Applicant would like to rezone the subject property to City M-1 (City of Springfield, General Manufacturing District). Mr. Neimayer stated the Twp I-2 zoning allows for I-1 district uses, which in turn allows for "B" (Business) District uses. City M-1 zoning does not allow for business uses. He stated staff recommends the Applicant's request to rezone the subject property from Twp I-2 to City M-1 be approved as presented. He stated the main concern is the height restriction of Twp I-2. He noted that M-1 does not have a height restriction.

Mrs. Roberge stated Springfield needs new businesses and this would help.

Chairperson Hanlon asked if there were any questions for staff.

Hearing no questions for Staff, Chairperson Hanlon asked if the Applicant wished to speak.

With no questions from the Board, Chairperson Hanlon asked for a motion.

Mr. Neimayer introduced Dick Shaw and Charles Morris as new members

Mr. Neimayer showed board members the Development Tab on the GIS and explained it would be live soon. He reviewed with them where to find the information on the Auditor's website.

Mrs. Roberge asked if a list of licensed contractors could be added to the website. Mrs. Tuttle explained that the County only licensed specialty contractors (HVAC, Electrical, Plumbing, Refrigeration). The County does not license general contractors. She explained that the City of Springfield licensed the specialty contractors and general contractors. Mrs. Tuttle explained the information should be on the County and City websites and not the GIS. Mrs. Roberge tasked County and City staff to put the information on its website.
