

The Board of Clark County Commissioners met in regular session pursuant to adjournment in accordance with Section 121.22 O.R.C. (Sunshine Law) in the Commission Chambers, 3130 East Main Street, Springfield, Ohio.

Commissioner Wilt called the meeting to order and introductions were made.

*Agenda Review:*

Ms. Hutchinson reviewed the agenda.

Resolution 2022-0747 acknowledged annual report from Clark County Prosecutor's Office. The report was emailed to the Commissioners.

Resolution 2022-0748 authorized intra-fund transfer from the Treasurer's Office. The Treasurer is moving funds from operating expenses to personnel and fringes.

Resolution 2022-0749 approved Supplemental Appropriations. One appropriation is for the Recorder from the Technology Fund. The other appropriation is for the IV-E Contract, which is a reduction. Commissioner Wilt asked why there was a reduction. Ms. Hutchinson said it is possible they did not use the funds or because the department was too far into the year and did not use the funds. It could also be the department did not get the contract or the grant.

Resolution 2022-0750 approved the travel expenses for the week.

Resolution 2022-0751 set date and time for the Public Hearing for Rezoning Case Z-2022-10. The hearing is set for Wednesday, October 19, 2022.

Commissioner McGlothlin asked how long the amount of the contract would cover for advertisement. Mr. O'Neal was not sure but thinks it is for a quarter of a year. Commissioner Wilt added it is probably budgeted through the end of the year.

*Commissioner Updates:*

Rittenhouse said she went to Oesterlen and took a tour. They have a new CEO, Mr. Ware. He is a very energetic and excited to revive Oesterlen. Commissioner Rittenhouse plans to attend their December board meeting.

Commissioner Rittenhouse also attended the Harvesting Hope Family Initiative. The Harvesting Hope dinner was nice. Commissioner Rittenhouse said they do many great things for the community and for younger kids. They educate and offer mental health services.

Commissioner Rittenhouse said she attended Mental Health Services Ribbon Cutting for the youth mental health facility and toured their facility. As a community, all of these things together keep chipping away at the youth and mental health services.

Commissioner Rittenhouse said she attended the Heritage of Flight Festival in New Carlisle. It was well attended. Commissioner Rittenhouse said she will also be at the Enon Apple Butter Festival on Sunday.

Commissioner McGlothlin said he attended New Carlisle Rotary where Captain Elliott spoke. He said she was well spoken.

Commissioner Wilt said the County needs to respond to Ms. Brown regarding the Tilly Lane issue. Commissioner Wilt wanted to verify Mr. Thompson is looking into that situation.

Commissioner Wilt asked Commissioner Rittenhouse if she could attend the Dayton Walk of Fame. Commissioner Rittenhouse said she can attend next Wednesday. Commissioner Wilt said A.B. Graham would be inducted into the Walk of Fame.

Commissioner Wilt said there is a CCLEAT meeting but she will not be able to attend.

Commissioner Wilt said the County has gotten inquiries from residents regarding broadband availability. She would like to centralize the inquiries so there is one person handling the calls. Mr. Cooper said he would handle those inquiries. Mr. Cooper will contact the representative at Spectrum.

Commissioner Wilt asked Mr. Cooper where the County is on the luminaries. Mr. Cooper said he is in the process and he will talk to her about it.

*County Administrator Updates:*

Ms. Hutchinson said Spectrum finally submitted a draft of the contract. There was something on the contract the County could not agree to regarding indemnification. The county has sent it back and as soon as Spectrum submits the updated contract, the County can proceed. This is for the second phase of broadband.

Ms. Hutchinson said that last week our Solid Waste hosted the Ohio Associate of Litter Prevention and Recycling Conference. It was the first time the County has hosted an event like this. Ms. Hutchinson said it was good for Springfield and Clark County to get on the State's radar.

Ms. Hutchinson asked if the Commissioners would be interested, in the next couple of weeks, to have Ms. Wagner come in and update on reentry. Ms. Hutchinson said within the next month Ms. Wagner expects to see clients. All three Commissioners agreed she should come to a Commission Meeting. Mrs. Hutchinson said Ms. Wagner is also speaking at the Springfield Rotary in November.

Ms. Hutchinson said the County is about ready to start on the budget. Next month will begin the budget meetings with all the departments.

The Board reviewed the calendar and events.

Commissioner Wilt told Mrs. Conley she is sorry for her loss and offered her a few minutes to speak.

*Audience Comments:*

Tracey Conley said five months ago, her daughter and her daughter's friend were walking a dog on Crabill Road and were hit by a car. Her daughter did not make it. Her daughter's friend, Tori, is recovering. They have been waiting for months for a meeting with the Prosecutor. Mrs. Conley said, according to the Ohio Victim Rights booklet, the victim's family has a right to confer with the prosecutor regarding the case. Prosecutor Dan Driscoll has refused to speak to them. On Tuesday, October 4, they went to the Prosecutor's office but the Mr. Driscoll refused to speak to them stating their attorney was not present. Mrs. Conley said they only have an attorney for the civil case, not the criminal case. She said only misdemeanor charges were filed against the driver and those charges only apply to her daughter, not to the other victim hit by the car. Mrs. Conley said the driver tested positive for marijuana and several witnesses heard the driver say he was on the phone at the time of the accident. She said they feel a meeting with the Prosecutor is not asking too much. Mr. Driscoll will not call them back or see them in person. Mrs. Conley said Mr. Driscoll has no compassion. Mrs. Conley asked the Commissioners who holds the County Prosecutor accountable for his actions.

Commissioner Wilt said the voters of Clark County hold him accountable. Commissioner Wilt said as Commissioners, it is their duty to handle the County Budget. Commissioner Wilt said she is very sorry to hear this was their experience with the Prosecutor's Office. Commissioner Wilt said she is happy to make a phone call to the Prosecutor for the family. Commissioner Wilt also said Sydney Dawes is here from the Springfield News-Sun and has access to the public record as well.

Commissioner McGlothlin said he is very sorry for what they are going through and, unfortunately, the Commissioners have no control over the Prosecutor's Office. He feels, if the Commission President will speak to Mr. Driscoll, it could possibly help.

Commissioner Rittenhouse said she is very sorry for their loss. Commissioner Wilt asked Mrs. Conley if she has reached out to the Attorney General. Mrs. Conley said the Attorney General's office said all the family can do is file a complaint with the Bar Association. Commissioner Wilt will follow up with Ms. Conley after she talks to Mr. Driscoll. She will also help in any way she can with the Attorney General's office.
